## **Individual Event Entries (Selection)**

Maximum 2 entries per event for respective gender provided both swimmers have achieved the qualification time. If more than 2 swimmers have achieved the QT or faster time, then the fastest 2 times will be considered for entry.

Qualification time is the 6<sup>th</sup> place time of finals at 19<sup>th</sup> Asian Games, Hangzhou as per MYAS circular no 70-9/2025 dated 24.09.25. Any relaxation to 6<sup>th</sup> place criteria if issued by MYAS (GOI) after publication of this document, the revised QT shall be taken in consideration and suitable modification to the qualification time standards will be issued at the sole discretion of Swimming Federation of India.

## **Qualification Period**

21 Sep 2025 up to 30 June 2026

## **Qualification Events**

International events (50M LCM) conducted by NF's affiliated to World Aquatics (within the qualification period) including the 11<sup>th</sup> Asian Aquatics Championship 2025, 79<sup>th</sup> Senior National Championship 2026.

## **Relay Events (Selection)**

Provisions of Sr No 4.1.III (a) and Sr. No 6 of MYAS circular no 70-9/2025 dated 24.09.25 shall be applicable, across all relay events for Men, Women & Mixed Gender.

For relay teams qualified to participate as per MYAS guidelines, the individual swimmers will be selected as follows:

### **Freestyle Relay Team Selection**

For this purpose, the fastest times from respective individual events shall only be considered (individual time from a relay event will not be eligible for consideration). SFI has full discretion to enter a reserve team member provided that the team still achieves the 8<sup>th</sup> place time after substituting the 4<sup>th</sup> seed player with the individual time of the reserve swimmer for the same event. No separate request for separate time trials or split times will be considered.

### **Medley Relay Team**

SFI shall enter a relay team for all medley relay events (including mixed relay) where total 4 swimmers have collectively achieved the published qualification time for such relay event and clearance by MYAS. Swimmer's will be selected based on the fastest individual time in 100M event for respective stroke recorded within the qualification period as given in this Qualification System Asian Games.



## **Eligible Meets for Relay consideration**

Times achieved in individual events at all eligible competitions shall also be eligible for Relay Events selection for 20<sup>th</sup> Asian Games 2026.

## **Mandatory Participation**

Swimmers are required to participate in 79<sup>th</sup> Senior National Championship 2026 in all events for which they wish to be selected for participation in the 20<sup>th</sup> Asian Games. This is applicable even if the swimmer has achieved the qualification time for such event/s at an earlier eligible competition or is yet to achieve the qualification time. The fastest times clocked in all eligible meets including the 79<sup>th</sup> Senior National Championship shall be considered for qualification.
